City of Newcastle is proposing the following traffic or parking amendment:

In January 2024 CN installed updated parking restrictions in King Edward Park (York Drive) and Strzelecki Lookout Carpark. Since that time, parking occupancy rates in the nearby area have been observed as having increased, and residents of the area have approached Council seeking an improvement to parking conditions.

To improve amenity and parking turnover in the area, it is proposed to install 2P ((9am - 5pm, Monday to Friday, Permit Holders Excepted Precinct 2) restrictions along both sides of Bingle Street The Hill, and parts of High Street, The Terrace and Cliff Street, replacing existing unrestricted parking.

The proposed changes will allow eligible residents to park with a permit and provide a higher rate of parking turnover for the public at the location. If responding, please include specific comments referring to specific streets if you do not support all changes.

Submissions

Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the proposed traffic or parking amendment. The submissions must specify:

- the reference number TR2024/00953,
- the submitter's name, residential address, contact number; and preferably an email address, and
- whether the submission is in support or objection of the proposal.

Submissions must be made in writing and should be lodged via the [online submission form](#) on City of Newcastle's website.

Alternatively, submissions can be made by mailed to PO Box 489, Newcastle NSW 2300 or delivered in person to the Customer Service Centre at 12 Stewart Avenue, Newcastle West NSW 2302.

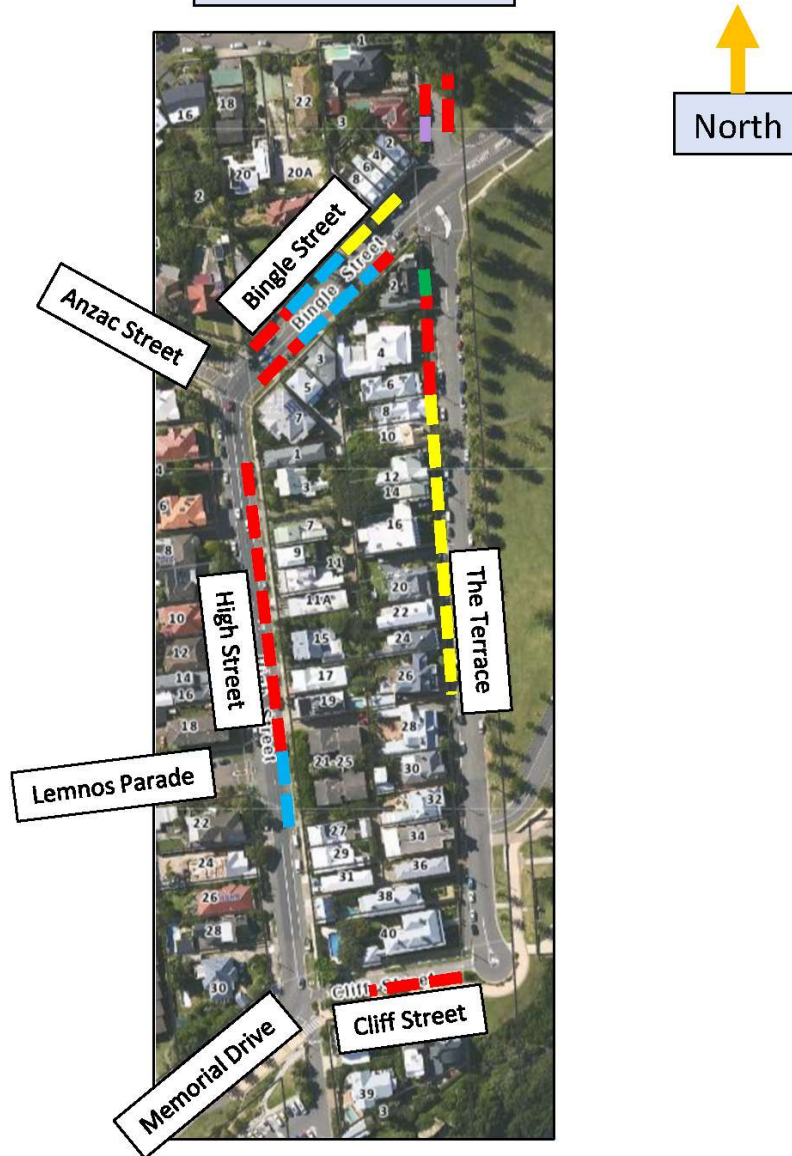
All submissions received are considered 'Open Access Information' under the Government Information (Public Access) Act 2009 (GIPA) and therefore may be made available to the public.
