City of Newcastle is proposing the following traffic or parking amendment:

In October 2023, CN installed updated parking restrictions in Grey Street in support of CN's adopted Parking Plan. Since that time, parking occupancy rates have been monitored as part of our ongoing planning within the area. Recent inspections have showed parking rates of below 50% in the street, which is below the 85% target set in the Parking Plan. Therefore, changes can now be considered.

To improve amenity and better match parking restrictions to community usage, it is proposed to replace existing 2P (9AM-5PM, Mon-Fri, 9AM-1PM, Sat, Precinct Parking Excepted Precinct 15) restrictions with 4P (9AM-5PM, Mon-Fri, Precinct Parking Excepted Precinct 15) restrictions, where present within Grey Street Wickham.

Please note that all existing resident parking permits will continue to be valid for precinct 15, as noted on the displayed regulatory signage.

Submissions

Any person, during the specified submission period, may make submissions to the City of Newcastle concerning the proposed traffic or parking amendment. The submissions must specify:

- the reference number TR2024/00940,
- the submitter's name, residential address, contact number; and preferably an email address, and
- whether the submission is in support or objection of the proposal.

Submissions must be made in writing and should be lodged via the [online submission form](#) on City of Newcastle's website.

Alternatively, submissions can be made by mailed to PO Box 489, Newcastle NSW 2300 or delivered in person to the Customer Service Centre at 12 Stewart Avenue, Newcastle West NSW 2302.

All submissions received are considered 'Open Access Information' under the Government Information (Public Access) Act 2009 (GIPA) and therefore may be made available to the public.

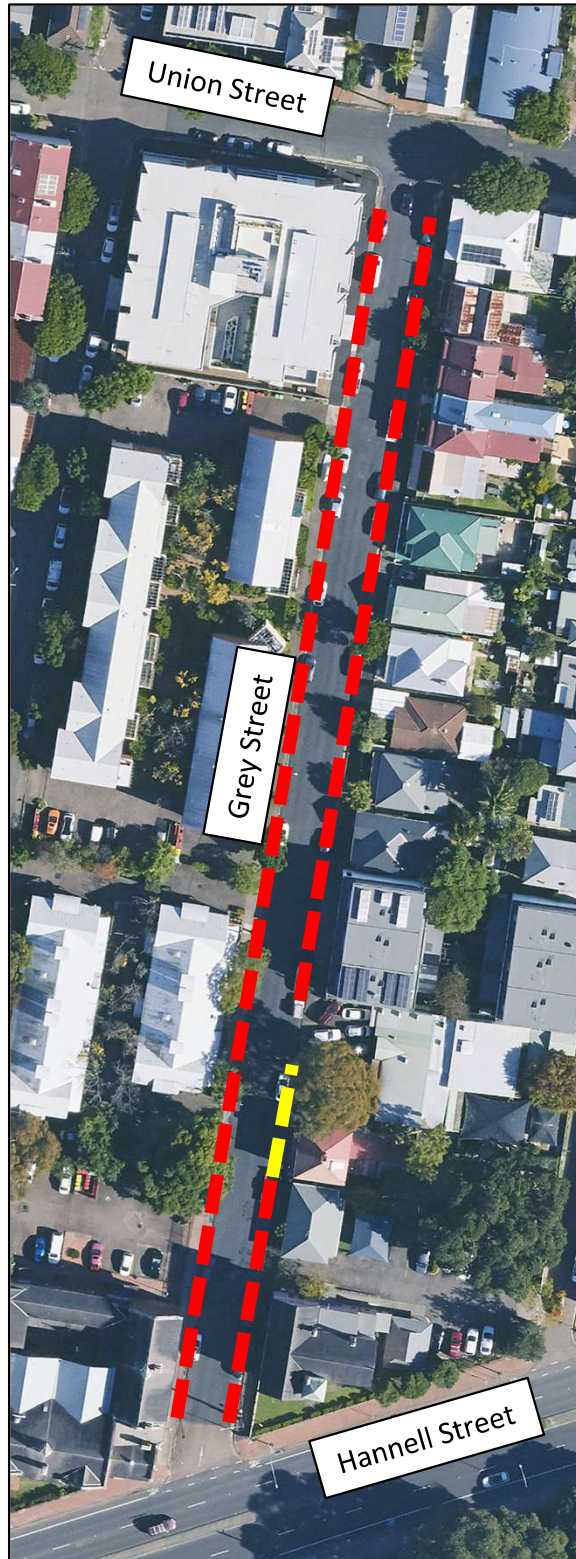
Following the closure of the submission period, the proposal and submissions received will be considered by the Newcastle City Traffic Committee at an upcoming meeting.
